Terms & Conditions

Prices/Room Hire

A room hire fee applies. The amount charged varies based on the space required and number of expected guests. Full club members are entitled to a 20% discount on room hire. Our Function Manager will confirm pricing during your initial consultations.

All prices quoted are GST inclusive, where GST is applicable.

Further costs may apply for public holidays.

There is a \$150.00 per hour fee applicable for events that exceed the package times.

Tentative Booking

Wakes can be tentatively booked and held for two weeks. If confirmation is not received at the close of business on the 14th day, we will assume that you no longer require us to hold this date and that we can make the date available to others.

Confirmation

Confirmation of your wake must be received in writing with a completed and signed copy of the booking agreement, along with the required room hire payment (if applicable). An invoice will be issued for 10% of the expected total cost of the function 4 weeks prior to the event date.

Payment and Final Numbers

Final guest numbers are required 7 days before the event date, which will confirm the minimum number to be charged. After this date, increases in guests will be accepted but not decreases. Final accounts are to be settled 5 days prior to the event date. Payment can be made by cash, bank cheque, credit card, EFT.

For Beverage Tabs a bar account will be made up at the end of the wake and must be paid for in full at the conclusion of your event. Credit card details need to be provided prior to your event to be able to open a bar tab. Acceptable forms of payment on the day include, cash, credit card (surcharge applies) and EFTPOS.

Food and Beverages

It is necessary to provide your menu selection at seven (7) working days prior to the date of the wake. Please note that due to seasonality some menu items are subject to availability.

It is a policy of Northbridge Golf Club and the Office of Liquor, Gaming and Racing that individuals or outside organisations are not permitted to provide their own food or beverage for events held at Northbridge Golf Club.

Responsible Service of Alcohol (RSA)

Northbridge Golf Club is obliged to abide by State Government regulation in regard to the responsible service of alcohol. Intoxicated persons, minors and those whose behaviour is considered by management as disorderly will be refused beverage service and may be asked to leave the premises. It is your (the Client's) responsibility to ensure orderly conduct of your guests. Management reserves the right to call police and/or terminate the function, without refund of any monies, should such behaviour present a problem to guests, staff or neighbours.

Patrons and their guests are not permitted at any time to bring their own alcohol on premises. If a person is found to have supplied their own alcohol Staff reserves the right to ask the patron or guest to leave the premise.

Damage, Breakage or Loss of Property

Northbridge Golf Club will take care, however the Client is responsible for the safekeeping of personal belongings, merchandise and gifts. Northbridge Golf Club will not accept any responsibility for the loss of or damage to any such property, before, during or after the wake. If required, the Client should arrange its own relevant insurance

Terms & Conditions

The Client will be financially responsible for damage to club property during events. This includes any damage to the building, facilities and furnishings on the property; and for loss however arising, as a result of any action by your guests or contractors (decorators, musicians, etc.).

Please ensure decorators and technicians are made aware of this. There will be an additional charge for any necessary repairs or excessive cleaning which will be passed directly to the client.

Pricing Policy

The Club will endeavour to maintain the costs as originally quoted but prices are necessarily subject to change, particularly where bookings are made well in advance.

External Contractors

All external contractors must be advised to the Northbridge Golf Club prior to the work and are fully subject to management approval. Northbridge Golf Club reserves the right to apply limits/ restrictions on these contractors so as not to impact on the venue and surrounds.

Unforeseen Circumstances

In the event of inability to comply with any of the provisions of agreed services by virtue of any cessation or interruption of electricity, gas, water supplies, industrial dispute or equipment failure, unforeseen contingency or accidents, Northbridge Golf Club reserves the right to cancel any booking and refund any prepayment for deposit at any time.

Event Conduct

The client agrees to conduct any function in an orderly manner, respecting the rights of other clients and staff. All conduct must be in full compliance with all applicable laws.

Cancellation of Booking

Northbridge Golf Club, in good faith, undertakes to provide services detailed in the quotation. If the client needs to cancel their event, the following fees apply:

- Cancellation less than 14 days prior to the event - the 10% deposit is forfeited along with the room hire fee. An exception applies where the event has been moved to a mutually agreed alternate date.*
- Cancellation less than 7 days prior to the event - 90% of the agreed event total is payable.
