# Beverages

The following two drinks options are available for Corporate Golf Events:

- Bar Tab (May be unlimited or limited by value and/or drink type)
- Guests Pay as You Go (Guests purchase their own drinks)

If you select to run a bar tab, you may nominate what drinks you would like to be available and/or set a tab limit. Our bar staff will monitor this throughout your event. If requested, the bar tab may be increased during the day.

Licensing Laws dictate that no beverages may be consumed other than those supplied by the club.



# Terms & Conditions

## Prices

All prices quoted are GST inclusive, where GST is applicable.

## Booking Confirmation

A booking will be considered confirmed when the signed Booking Form is returned along with deposit payment. Functions can be tentatively booked and held for 2 weeks.

If the Booking Form and deposit payment isn't received within 14 days of the original reservation, management reserves the right to cancel booking and allocate the date to another client. The deposit will be deducted from the total cost of your event.

## Guaranteed Numbers

Final numbers must be confirmed no later than seven (7) days prior to the date of the event.

## Food & Beverages

It is necessary to provide your menu selection at least fourteen (14) working days prior to the date of your function. Please note that due to seasonality some menu items are subject to availability.

It is a policy of Northbridge Golf Club and the Office of Liquor, Gaming and Racing that individuals or outside organisations are not permitted to provide their own food or beverage for events held at Northbridge Golf Club.

Final numbers for catering purposes (including special dietary requirements) must be received by the Club at least seven (7) working days prior to the date of the event. This number will be the basis upon which the invoice for the event is prepared, irrespective of whether a lesser number attends on the day. If more patrons attend, the number present will be the basis of our charges. Beverages are charged on a consumption basis and must be paid in full on the day of the event.

## Golf Cart Reservations & Charges

There are twenty-eight (28) electric golf carts available for hire for corporate groups. Additional carts may be hired from a third-party provider, the charge for which will be added to the cost of the day. Third-party cart hire must be approved by Northbridge Golf Club prior to their booking, and availability will depend upon the third-party hire company.

## Damage Responsibility

The client accepts responsibility for costs for any equipment, third party equipment hire, furniture, fittings, parts of the building or golf course that is damaged by their delegates and guests. Northbridge Golf Club will not accept responsibility for the damage, or loss of any property left on the premises prior to, during, or after the function. Clients should arrange their own insurance where required.

## Cancellation of Booking

Northbridge Golf Club, in good faith, undertakes to provide services detailed in the quotation. If the Client needs to cancel their event, the following fees apply:

- Cancellation less than 4 weeks of the event - the deposit is forfeited
- Cancellation less than 14 days prior to the event - 100% of quoted green fees and cart hire is payable
- Cancellation less than 7 days prior to the event - 100% of quoted green fees, cart hire and catering costs is payable

## Cancellation Due to Bad Weather

In the event the Client wishes to cancel their event due to actual or potential bad weather and where the Club continues to make the course available, the client will be required to pay 100% of the total amount.

Where Northbridge Golf Club closes the golf course and declares the course unfit for play, the total amount paid will be returned to the Client conducting the golf day or an alternative date will be offered. Catering arrangements will be available to proceed subject to discussion and if mutually agreeable, the timing of service may be varied.

## Unforeseen Circumstances

In the event of inability to comply with any of the provisions of agreed services by virtue of any cessation or interruption of electricity, gas, water supplies, industrial dispute or equipment failure, unforeseen contingency or accidents, Northbridge Golf Club reserves the right to cancel any booking and refund any prepayment for deposit at any time.

# Terms & Conditions

## Signage

Signage is welcomed. It will be placed by our Course Staff at tee locations, the practice putting green and at the front entrance to the clubhouse. The Club accepts no responsibility for storage of signage prior to, or after the event. Any signs not collected fourteen (14) days after the golf event will be disposed of.

## Care of the Golf Course

All players are to carry and use a sand bucket to repair all divots on the fairways. Players are also required to repair pitch marks on greens. Bunkers must be raked after use.

Electric Golf Carts are to be kept at least 10 metres from greens where paths are not provided and no more than two persons are to travel on the golf cart at any one time. Reckless or careless driving, as determined by Northbridge Golf Club staff, will result in golf cart confiscation.

## Function Conduct

The Client agrees to conduct any function in an orderly manner, respecting the rights of other clients and staff. All conduct must be in full compliance with all applicable laws.

## Clubhouse Damage

The Client is financially responsible for any damage sustained to Northbridge Golf Club property during functions. The use of walls for display material is strictly not permitted, nor is the use of nails, staples or tape attachment to floors or ceilings.

## Payment

Guarantee of Payment: The Client and Authorised Person (if applicable) are jointly and severally liable to pay all monies to Northbridge Golf Club pursuant to this agreement. Where the invoice has been requested to be addressed to another person, company or entity, personal liability for full payment remains the responsibility of the Client and Authorised Person.

Pre-payment: Northbridge Golf Club will provide the client with an estimated cost of the event. The client must make payment of this estimated cost by credit card (1% surcharge applies to credit cards, 1.5% to AMEX cards) or direct debit to Northbridge Golf Club's account no less than five (5) working days prior to the commencement of the event. Northbridge Golf Club shall be under no obligation to proceed with the event unless such payment is made.

## Hospitality Cart

A refreshment cart and driver can be made available for your event, depending upon the number of players expected to play on the day. Please note that due to occupational health and safety policy requirements, the driver of the refreshment cart must be a staff member of Northbridge Golf Club. Clients are able to provide a representative on the cart, to assist with the distribution of refreshments. However, this person will not be permitted to operate the cart.

## Clubhouse Use

The Client and their guests will be entitled to use of the Clubhouse in order to conduct the various stages of your event, and specific room choices will be met where possible, depending on other events scheduled at the Club on the day. Guests will be given access to all member facilities including warm-up hitting nets, practice putting green, locker rooms and shower facilities.

There is parking available on the premises, and it is the Client's responsibility to notify their patrons and guests that they park at their own risk.

## Responsible Service of Alcohol (RSA)

Northbridge Golf Club staff are not permitted to serve alcoholic beverages to intoxicated patrons under the Responsible Service of Alcohol Act. Alcohol cannot be removed from the Northbridge Golf Club premises and must be consumed within the defined functions areas. The Client, patrons and their guests are not permitted at any time to bring their own alcohol on premises. If a person is found to have supplied their own alcohol, staff reserve the right to ask the patron or guest to leave the premises.
